It is to inform you that on the basis of enhanced compensation awarded by the Hon'ble ADJ Court vide order dated 05.05.89 No. 36/88 pertaining to the acquired land for the development of Sector-5, Faridabad, the recovery rate of additional price (1st EC) has been worked out @ Rs. 285.52 for General Category.
