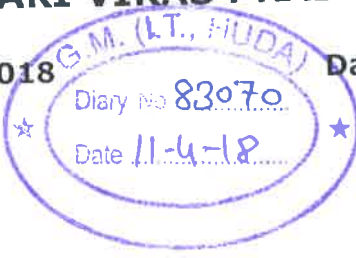

It is to inform you that on the basis of enhanced compensation awarded by the Hon'ble ADJ Court in No. 193-L/05 dt. 24.12.2010 and Hon'ble High Court in No. 2250/11 dt. 01.09.14 pertaining to the acquired land for the development of Sector-4 Ext. and 5, Rohtak the revised recovery rate of additional price (1st EC) has been worked out are as under :-
